TERMS OF PURCHASE

___ LIMITED AKC REGISTRATION: This puppy is being sold with LIMITED AKC Registration. It is understood by the buyer that you will receive the proper AKC registration papers to register your puppy/dog with a limited registration. This means that he or she will not have breeding rights with the American Kennel Club.

___ FULL REGISTRATION: This puppy is being sold with FULL AKC Registration which allows the buyer full rights as owner for breeding, showing, and reselling with the American Kennel Club, with the exception of the specific action stated below.

RESTRICTION: The buyer agrees to not place this animal in an animal shelter, animal rescue, and agrees to not using this animal for testing in animal research in any way.

AKC NAME- The buyer agrees to use the prefix CLARK MEADOW at the beginning of the Dog's registered name.

NOTICE TO BUYER OF GOOD FAITH: All canines have the potential for genetic or congenital disease. Due to the nature of these particular diseases it is the job of the breeder, through selective breeding, to try to minimize the possibility of these conditions - in good faith. Please read, to your full understanding, the following sections of this contract concerning any contagious or hereditary defects. All puppies will be examined by a licensed veterinarian before they are shipped or delivered to the buyer.

CONTAGIOUS ILLNESS: All puppies are examined by a licensed veterinarian before they are flown, shipped or delivered to the buyer. To the best of the breeders' knowledge, this puppy has no known diseases or illnesses that would adversely affect their health. This puppy is guaranteed to be free of untreatable contagious health conditions. Sometimes, relocation and/or travel can cause stress to a young puppy, and an upset stomach or not eating properly for a few days can be a common symptom of travel and being separated from their litter. This will clear up with in a few days. If it does not, have your puppy examined by your veterinarian. Stress can also bring to the surface certain conditions such as Coccidiosis which is very treatable. A condition such as this would not be included as a reason for a puppy's return to the seller.

GUARANTEE: Your puppy will be guaranteed for 1 year from date of purchase against a moderate or severe hip, elbow, cardiac, or cataract condition with the understanding the buyer will feed the NuVet Plus vitamins during the first year of this puppies life. We require the use of the PennHIP hip test, and warranty against a PennHIP rating below 50%. If a structural condition, as mentioned, does arise we do choose to replace that puppy. The breeder reserves the right to a second opinion of their choice.

Therefore, if your puppy should exhibit these conditions within your one year from date of purchase time frame, and meets the above mentioned criteria, the buyer may receive a replacement puppy of equal value, following the return of this puppy to the seller, and when the seller has another litter available to make this possible. Under NO circumstances is the seller to be held liable for any/all veterinarian or other expenses incurred by the buyer.

Your puppy will need to eat a high quality puppy food and you will need to follow the recommendations on the label and/or the instructions from your vet as to the proper amount to feed your puppy. Due to the varying kinds of dog food on the market and the different environmental conditions that dogs come on contact with, we will not guarantee the dog unless they are given NuVet Plus daily at the manufacturer's suggested dosage for the 1 year from date of purchase. Failure to do so makes this guarantee null and void. For your convenience, you may order directly from the manufacturer. "We are not responsible for accidents, negligence or poisonings."

This puppy is guaranteed to be in good health at the time of purchase. In order for this guarantee to be valid, the buyer is required to take their puppy to a licensed veterinarian for their well check up within 72 hours of purchase. If your puppy is found to have a contagious disease that is untreatable or found to be hereditably ill, then a letter from a licensed veterinarian stating so must be presented to the seller within 10 days, and the puppy may be returned at the buyer's expense and the buyer make pick out another puppy if one is available. If another puppy is not available at this time then the buyer will be able to pick out a puppy from the next available litter. The seller will not be obligated to pay for any expenses incurred by the buyer or by the buyer's veterinarian. All puppies will be examined by a licensed veterinarian before they are shipped or delivered to the buyer.

VOIDING OF GUARANTEE / CONTRACT:

- 1.) If the buyer allows this dog to become obese at any time. Recent research does contend that obesity can greatly contribute, if not actually be a cause of hip and joint problems in large breed dogs. Although these disorders tend to be hereditary; poor diet, over feeding, or improper exercising of a puppy is a known contributor to these disorders.
- 2.) If there are any signs of neglect or abuse to your dog.
- 3.) If injuries occurred while under care of buyer, such as broken bone, trauma, etc.

- 4.) If the buyer does not follow through with shot requirements and vet visits

in a timely fashion.

- 5.) If the buyer does not feed this dog a recommended premium quality dog food. Low quality dog foods are a sure way to malnourish or adversely affect the development of a puppy. While the puppy may appear to be at the appropriate weight for their age low quality dog foods fail to supply the necessary proteins and nutrients required for proper growth of the muscular skeletal system, and proper growth of the brain and neurological systems. The breeder strongly urges the buyer to feed only high quality dog food.
- 6.) If there is any evidence of abusive exercising such as a treadmill or track running. While the breeder does want your dog to play sensibly, it must be in a reasonable manner, as not to do serious damage to joints and bones through excessive exercise.
- 7.) If the buyer fails to give their puppy the NuVet Plus vitamins previously mentioned in this contract.

By signing this contract the buyer acknowledges having read and understanding the terms of this agreement.

AGREEMENT BETWEEN PARTIES: All parties agree by signing to follow the terms of this agreement. This contract contains the entire agreement between parties. Any changes to this contract must be binding through signature only, and not on verbal agreement. Verbal changes will not be considered legal or binding to this buyer or seller. No legal fees shall be incurred to the seller or the buyer, other than those already listed or stated in this contract.
